Wine Challenge 2018

Shiraz SA rig hiermee 'n uitnodiging aan alle produsente van Shiraz om in te skryf vir die 2018 “**Shiraz SA Wine Challenge**” wat vanjaar vir die sesde keer aangebied word.

Shiraz SA bied die kompetisie aan met die ondersteuning van Vinventions SA.

Die doel van hierdie kompetisie is om 12 plaaslike Shiraz-wyne asook 3 Shiraz-versnitte aan te wys en sodoende uitvoering te verleen aan die organisasie se hoof-doelstelling, “*Om die beeld van wyn gemaak van hierdie vareïteit uit te bou en te bevorder.*”

Inskrywings sal blind geproe word en beoordelaars sal hierna die wyne op 'n ranglys plaas wat uiteindelik die 12 Shiraz- en 3 versnitwenners sal bepaal.

Shiraz SA herewith extends an invitation to all producers of Shiraz to submit their entries for the 2018 “**Shiraz SA Wine Challenge**” which is presented for the sixth time this year.

Shiraz SA presents this competition with the support of Vinventions SA.

The aim of this competition is to select 12 local Shiraz wines as well as 3 Shiraz blends to further the organisation's main objective, “*To develop and promote the image of wine produced from this cultivar.*” Entries will be tasted blind and judges will rank these wines to determine the eventual 12 Shiraz and 3 blend winners.

- 2.3 An additional fee of **R300.00** per wine will be charged for late entries both for members and non-members.

3 REQUIREMENTS TO PARTICIPATE

3.1 Producers must have the following quantity in stock:

- A minimum of 50 cases (12 x 750ml) or
- 100 cases (6 x 750 ml) (600 bottles)

NB This stock must be available at the time of judging until the awards ceremony.

3.2 The organisers reserve the right to physically conduct inspections to verify stock and may demand proof that stock is indeed available for sale.

4 WINE FOR JUDGING

4.1 **Shiraz:**

Wines entered in this category must be certified by the Wine & Spirits Board as **Shiraz** (i.e. 85% minimum Shiraz)

4.2 **Shiraz Blends:**

Wines entered in this category may be a blend of Shiraz with any other cultivar(s) provided that Shiraz forms the dominant percentage.

4.3 Any vintage may be submitted.

4.4 There is no restriction on the number of wines a producer may enter.

4.5 Wines entered must be bottled, labelled and finally certified. No tank samples will be allowed.

4.6 If a wine is marketed under different labels, it may only be entered once i.e. under one of those labels

4.2 **Shiraz-versnitte:**

Wyne wat in hierdie kategorie ingeskryf word mag 'n versnit van enige kultivar(s) wees op voorwaarde dat Shiraz die oorwegende persentasie vorm.

4.3 Enige oesjare mag ingeskryf word.

4.4 Enige aantal wyne mag ingeskryf word.

4.5 Wyne wat ingeskryf word moet gebottleer, geëtiketteer en finaal gesertifiseer wees. Geen tenkmonsters word toegelaat nie.

4.6 Indien 'n wyn onder verskillende etikette bemark word, mag dit slegs onder een van die etikette ingeskryf word.

5.5 Kindly note: It is not necessary to submit original entry forms with your delivery.

6 COMMITMENTS FOR PRODUCERS OF FINALIST WINES

6.1 Producers of wines that progress to the **25** Shiraz finalists will supply Shiraz SA with **24 x 750ml labelled bottles** for the Awards Function as well as marketing and promotion.

6.2 Producers of the **6** Shiraz blend finalists will supply Shiraz SA with **12 x 750 ml labelled bottles** for the Awards Function as well as marketing and promotion.

6.3 Producers will be informed in terms of the time, date and place for delivery of the above wines.

6.4 Producers failing to deliver stock as set out in this catalogue will be disqualified from the competition and any awards will be forfeited.

6.3 Produsente sal ingelig word in terme van die tyd, datum en plek van aflewering van bovermelde wyne.

6.4 Indien 'n produsent versuim om voorraad te lewer soos uiteengesit in hierdie katalogus sal sy wyn gediskwalifiseer word en enige toekennings verbeur word.

6.5 Producers in this round will supply the organisers with the following:

- **Logo and label in high res**
- **Pack shot in high resolution**
- **Wine description in Word document**
- **Contact details and web site in Word**
- **Photo of winemaker in high res**

7 GENERAL

7.1 Where two consecutive bottles of wine are found to be corked, the entry will be disqualified.

7.2 The results of the Shiraz Challenge will be final and binding and no ex post facto deliberation or correspondence will be entered into after the results have been announced.

7.3 The Management committee of Shiraz SA and the organisers of this competition shall not be responsible in any way for fruitless expenditure, loss or damage of whatever nature which may occur as a result of a participant's entry in this challenge.

7.4 A producer of a winning wine will receive 2 000 bottle stickers free of charge. Thereafter stickers can be purchased from **Coastal Labels** who will contact producers.

7.5 Producers will be contacted in terms of any additional promotional opportunities that may occur.

7.6 Please note that producers of winning wines are no longer required to keep a prescribed number of cases in stock for co-ordinated marketing and sales.

7.2 Die uitslag van die Shiraz Challenge is finaal en bindend en geen ex post facto korrespondensie of ander beredenerings sal gevoer word nadat die uitslag bekend gemaak is nie.

7.3 Die Bestuur van Shiraz SA en organiseerders van hierdie kompetisie sal op geen wyse hoegenaamd aanspreeklik wees vir enige vrugtelose uitgawe, verlies of skade van watter aard ook al, wat mag voortspruit uit 'n deelnemer se deelname aan hierdie kompetisie.
